**Description of the scholarships**

**Purpose**

The purpose of the scholarships is to encourage excellence in biostatistics.

**Benefit**

The benefit takes the form of payment of fees for one or more units of study for one year. Normally one unit per semester (two per year) will be awarded to each successful applicant, but variations from this may be made at the discretion of the BCA. \* Successful applicants will be invited to apply again in subsequent years while their BCA studies continue.

\*No one applicant will be awarded the scholarship more than two times for the duration of their studies.

**Eligibility**

Both current BCA students and applicants for study commencing in 2010 are invited to apply. Applicants must be Australian residents or in receipt of a current Australian Working visa.

These scholarships are NOT available to employees of the pharmaceutical industry. Applicants must not receive financial support from their employer during a year in which they hold a BCA scholarship.
